## What investment services and advice can you provide me?

We offer investment advisory services to retail investors such as you through the management of your separate account. As part of our standard services, we monitor each account on an ongoing basis, using our current model portfolios as a guide, and we typically furnish clients with portfolio appraisal reports on a quarterly basis. Our authority to manage a retail investor's account is usually discretionary, which means that you authorize us to select the identity and amount of securities to be bought or sold, subject to your chosen strategy and stated investment objectives. On occasion, we agree to manage accounts on a non-discretionary basis, which means that we must obtain the client's consent prior to transacting in any portfolio trades. For most retail investors' accounts, we primarily purchase exchange-traded funds ("ETFs"). When determined appropriate by us, we will also purchase publicly traded equity and debt securities and mutual funds. We do not impose a minimum account size for investment management services. Limitations on investments typically include limitations by plan sponsors, mutual fund selections of no-load or waived load funds, and any client-imposed limitations. We also offer short-term cash management services to high net worth clients. Clients can access the investment management services of unaffiliated third party money managers through a sub-advisory program. We offer financial planning services, at no additional cost, which focus primarily on retirement planning, retirement plan allocations and investments. We also offer billpay and reconciliation services for an additional fee, which is detailed further in the next section.

# What fees will I pay?

We charge a fee based on the total assets in your account. This fee, which is payable quarterly in advance, is calculated at an annual rate of 1% for amounts up to \$1 million and 0.75% for amounts up to \$3 million in your account. Once the portfolio reaches a breakpoint, we bill all assets under management in the portfolio at the lower rate. The rate for portfolios values in excess of \$3 million is negotiable. We bill short-term cash management services at a negotiable annual rate not to exceed 0.25%. The more assets there are in your account, the more you will pay in fees, and we may therefore have an incentive to encourage you to increase the assets in your account. Our fee does not include (and you will pay separately) any applicable charges imposed by custodians, brokers and other third parties such as brokerage commissions, transaction fees, custodial fees, wire transfer and electronic fund fees, and other fees and taxes on your account and on the securities transactions in your account. Money market funds, mutual funds, and ETFs also charge their own internal management fees. Fees for billpay and reconciliation services are separate from our investment advisory service fees. The minimum fee for billpay and reconciliation services is \$5,000 annually, based on the number of anticipated transactions and accounts

requiring reconciliation.

<u>Additional Information</u>: You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you.
